

IRS Data Retrieval Steps

Federal Regulations require that students and/or parents complete the IRS Data Retrieval Process or submit a tax return transcript or to verify their financial information.

- 1. Login into FAFSA application at www.fafsa.gov.
- 2. Select 2018-19 (if applicable).
- 3. Select make FAFSA corrections link.
- 4. Along the top tabs select "Financial Information".



5. After you choose "LINK TO IRS" - you will see this screen:
